Consent to the use and release of his/her name and likeness to be used in photographs, video recording, social media, television filming and recording of the event used in connection with the television broadcast, exhibition, distribution or promotion of the event in any manner and by any means, now or in the future, by Danse Élite Dance Competition; Élite Ballroom Foundation, Inc.; Jean-Philippe Milot, Laurence Bolduc, and/or the National Dance Council of Canada, Inc.*
